## 1 Homepage

#### Dear site visitors BitcoiNFT.cz,

I greatly appreciate your trust and place great importance on the protection of your personal data, both in storage and processing. All operations with this data are carried out in accordance with the applicable legislation and in particular in accordance with the General Data Protection Regulation, hereinafter referred to as "GDPR".

In this document, there is a detailed description of all personal data that I process or store, to the extent provided for in Articles 13 and 14 of the GDPR.

#### 1.1 Cookies files

To ensure proper functionality and enhance your experience, I use cookies on the website. These are small files that the server sends to your terminal device, which stores these files and then sends them back to the server each time you visit the site, depending on your settings. These files contain:

- cookie file name
- the actual file data
- validity period
- the domain for which it is to be used
- the server directory for which the cookie is valid

#### 1.1.1 Session cookies

These are cookies that are automatically deleted when you close your browser, on my site you will encounter them on the main page where a cookie file is set to verify if your browser is directing cookies. For a list of all cookies used, please see the following file: HERE

#### 1.1.2 Temporary cookies

There are files that have a lifetime of a certain, set period of time. I use them, for example, for display settings, storing login credentials, etc. For a list of all the cookies used, see the following file: HERE

#### 1.1.3 Purpose of processing

Ensuring the correct functionality of the website, optimization and increasing the comfort of visitors to the site.

#### 1.1.4 Legal reason

These are my legitimate interests, so I rely on Article 6(1)(f) GDPR, so the collection and processing of this data is not subject to your consent.

#### 1.1.5 Processing time

#### 1.2 Google analytics

I use Google analytics on my website. It is an analytical tool used to optimize websites. This tool analyses the behaviour of visitors to the website through pseudo-anonymised profiles that it creates based on cookie files. This software collects the following data:

- operating system
- previous visited page
- IP address
- query time

It is created by Google Inc., headquartered at Amphitheatre Parkway, Mountain View, CA 94043, USA. More information about this service can be found at HERE

#### 1.2.1 Purpose of processing

We only use this data to optimize the website and evaluate traffic.

#### 1.2.2 Legal reason

These are my legitimate interests, so I rely on Article 6(1)(f) GDPR, so the collection and processing of this data is not subject to your consent.

#### 1.2.3 Processing time

The retention period of these files is set to 180 days by default.

#### 1.2.4 Preventing storage

In the settings of your browser, it is possible to modify the storage of cookies or to prevent their storage altogether. However, it is possible that some features of my website may not work properly for you.

# 2 Your data protection rights

#### 2.0.1 Right to withdraw consent

You may withdraw your consent to processing at any time, in accordance with Article 7(3) of the GDPR, either in writing or by using the email contact details below. Please note that the withdrawal of consent does not affect the processing of data prior to the withdrawal of consent.

#### 2.0.2 The right to extract all your processed personal data

According to Article 15 GDPR, you can ask me if I process your personal data, what data I process and what I process it for. Of course, you also have the right to access the following information.

#### 2.0.3 Right to repair

According to Article 16 of the GDPR, you have the right to correct incorrect or incomplete personal data.

#### 2.0.4 Right to erasure

According to Article 17 of the GDRP, you have the right to have your personal data deleted from our system, provided that one of the following reasons applies:

- data are no longer needed for the purpose for which they were processed
- withdrawing your consent
- I am processing the data unlawfully
- objecting to it pursuant to Article 21(1) et seq. of the GDPR

#### 2.0.5 Right to restriction of processing

Under Article 18 of the GDPR, you have the right to ask me to restrict the processing of your personal data, provided that:

- the processing of your data is unlawful and instead of erasure, you request restriction.
- you deny the accuracy of the personal data provided
- by objecting, until a decision is made as to whether my reasons for processing outweigh yours.

#### 2.0.6 Right to portability

According to Article 20 GDPR, you have the right to obtain from me all your personal data that I process

#### 2.0.7 Right to object to processing

According to Article 21 GDPR, you have the right to object to the processing of your personal data, in particular in cases where the processing of your personal data is based on legitimate interests within the meaning of Article 6(1)(f) GDPR..

#### 2.0.8 Right to lodge a complaint with the supervisory authority
